

Active Member Registration



Have you noticed that you don't get all the communications that some other SPSW members get or that you are unable to view the meeting/remote

demo videos? In order to get all benefits for active members, you need to be registered on our website and signed up for our member communication email list. Only about half of our paid-up members are completely registered and signed up. If you aren't registered, it is an easy problem to correct. Open our webpage at www.spswoodturners.org and click on the "For Members" tab. The dropdown menu's first choice is "How to Register". Click on it, and there will be a short video that explains exactly how to get registered. After your registration is approved, the second step is required to complete the process. Go to our webpage and click on the "Member Communication Sign-up" under the For Members menu and follow the instructions.



Zoom Meeting If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)

- 1. The Zoom meeting invitation is only sent to active members. So, if you have not paid your dues since October 2019, you will need to go to the members tab on the SPSW website (spswoodturners.org) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.
 - Those of you who get the newsletter by snail-mail will need to get us an e-mail address where we can send your meeting invitation. Please send it to (membership@spswoodturners.org)
- Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!
- Information and Invitation Delivery Schedule:
 - Saturday, April 10th The Zoom Meeting Invitation will go out to our active member's distribution list.
 - i. This invitation contains a link that appears in blue letters. Just click it to join the remote demo on Thursday.
 - ii. Please save this where you can find it.
 - 1. If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
 - Wednesday, April 14th A reminder will be e-mailed to our active member's distribution list.
 - Thursday, April 15th Log into the meeting between 6:30 and 7:00pm
 - Carl's demo will start promptly at 7:00pm.
 - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
 - iii. Note: If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
 - Devices used to view the demo can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.
