Larry has 50 years of woodturning, having started in high school. There was, however, a 35 year layoff while finishing college, getting married, working as a computing manager in higher education, oil, and aerospace, and "in cooperation with his wife", raising



his two sons. When his wife bought him a small lathe in 1995 he once again picked up the craft. He now owns 5 lathes and not only makes

what he likes to call "Functional Art", but also teaches woodturning to all ages, including home schooled kids. He mentors other woodturners and is president of the Woodturners of Olympia. He has been actively involved in the youth program for the American Association of Woodturners (AAW) for 6 years and is now a candidate for the 2013 AAW board of directors.



This month he will be demonstrating "Making a Threaded Stacked Box." In this demonstration he'll be showing how to make a stacked box with threading using the Klein threading jig. He'll also discuss other options for threading and considerations for box design and sizing.

Deadline ... this ORIGINAL paper ballot must be received no later than October 19, 2012, so mail early. Photocopies will not be accepted.

Letter from the President



What a great demonstration this last month. Eric, as usual did a great job of explaining the way to turn a very thin walled bowl. He managed to help us learn about so many aspects of turning in a very comfortable manner. What a great teacher we have as a fellow member.

This month we have Larry Miller demonstrating threaded boxes. This should be a very informative and exciting demonstration. Larry is the president of the Olympia club. He is the only president they have had over the years and he has currently been nominated as a director of

the American Association of Woodturners, the AAW. He has managed to bring their club from a basic beginning with the help of our club to an outstanding club, which as you know, has a yearly symposium with well known turners and a local turner. I hope that all of you AAW members will vote for Larry in his bid to become a director. He has volunteered with Bonnie Klein every year working with the youth turning program. He has also been a tremendous help to me over the last two years giving me advise and help making the many advances for our club. This last month David Elsworth was the well known demonstrator. His stories were very interesting as he let us know about his past and really the beginnings of the AAW. Jim Leary was the local demonstrator and his demo was outstanding. He taught basic spindle turning and it was very informative. Since he turns at least a hundred spindles per month for local contractors and buyers his skill level is very high.


One story that David chatted about was a very unique turning situation. He has at his shop a very large lathe. The distance between the weighs is eighteen inches. A dear friend of David's was turning a very large object and was standing between the weighs with his tool braced under his right arm. He had a major catch and he was actually launched out of the lathe and fortunately he landed in a large pile of wood curls thus saving him any major injuries. This last month Tim Ramsaur, our secretary, was at my home for a turning session. He needed a large bowl for a wedding gift. His lathe is not large enough to turn a larger bowl. He brought a large bowl blank that had dried with some cracks and some unknown internal cracks. This blank was done by another turner. I was cautiously turning the bottom of the bowl on vacuum attempting to get rid of the many cracks. It was actually looking pretty good with little to no visual cracks. Fortunately for me I was not standing in line with the spinning bowl. That was not enough though. The bowl split apart and somehow managed to nick my cheek and nose. I learned a very big lesson. Even though something has never happened before we need to be prepared for the unexpected while turning. I was not wearing one of my many face shields. I did have safety glasses on but that did not save the scratch on my face. After applying a bandage to my nose I found a blank that I had turned and dried and we continued to make a fine gift for the wedding. Two things come to mind. First, never turn anything but good wood. If it is cracked it is firewood. There is always more wood, body parts are harder to come by. Second, always be prepared for the unexpected when turning. Be safe!

We had great weather for our picnic and wood auction. The bidding was good and there were many bargains on some very nice wood. We already have volunteers to head up the committee for next year's picnic and we hope to have even better wood to bid on.

One last thing, our club now has the capability to take credit cards for purchases of supplies and dues, etcetera.


I am looking forward to seeing you Thursday evening. Be safe and keep turning.




