July Demo: Our Interactive Remote Demonstrator will be Ed Pretty. Ed was one of the founding members of the Greater Vancouver (BC) Guild and has been woodturning since he was 9 years old.

Ed's program is titled "Beyond ABC". We have all heard the old ABC's mantra about how to safely cut wood at the lathe. This is a presentation of all the things that aren't covered when someone talks about "anchor - bevel – cut". Ed doesn't just present a list of "rules" for people to follow. Rather, he explains the logic behind the concepts so people can figure out how and why things happen and what to do about problems and concerns as they arise when working at the lathe. Dave Best highly recommends this as great program of newer woodturners, and a good refresher for the rest of us! Please join us for what I am sure will be a great demo!

Please Join Us For Our Remote Demos: I have talked to many of you that have joined us for these virtual demos. Each of you have reported how good they are. This is a benefit of membership. Zoom Meeting If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)

- The meeting notice is only sent to active members. So, if you have not paid your dues, please go to the members tab on the <u>SPSW website</u> (http://spswoodturners.org) and do so. Please note that it would normally cost more to attend one of these just one of these demonstrations in person than SPSW dues for the entire year.
 - a. Please note: Those of you that get the newsletter by snail-mail, will need to get us an e-mail addresswhere we can send your meeting invitation. Please send it to (membership@spswoodturners.org). You will also need either a smart-phone, lap top, or computer with video capability to view the demo.
- 2. Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. Again, it is quick, easy, and free!
- 3. We will email out "meeting invitations" on July 11th, the Saturday before our meeting and demonstration. This invitation will contain a link which can be used to log into both the practice session on Wednesday evening (July 15th), and Ed's remote demo on Thursday (July16th) evening. (see below for more information on the practice session). Log in to either or both at about 6:45 PM.
 - a. When you click on the link, you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
 - b. If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. But if you get our newsletters, the meeting invitation should come right into your inbox.

- c. Hint: I suggest people use a cell phone calendar reminder so they remember to log in for the meeting
- 4. We will send out an email meeting reminder in July 15th, the day before the meeting. (Several people indicated that they just forgot about the last meeting.)

- 5. On July 15th and 16th, just click on the link in that meeting invitation to join either the practice session, or the demo occurring on that evening.
 - a. It will load you right into the meeting waiting room. Just follow the on-screen directions to join with computer audio on the device you are using to view the program.
 - b. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
 - c. Devices can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.

For Zoom Security, Please Rename If Needed: We have a number of people that participate in the Zoom demos. When you join the session, we get a thumbnail photo with your name under it. If yours's comes up with some-

thing like "John's iPad", or just "John" we don't really know who you are, which is a security issue. So, if that happens when you join the meeting, please just click on your name, and then click "rename" and change it to your full name. It will help Ramon and I as we co-host the meeting. Thanks!

Practice Session Available: As mentioned above, Ed will conduct a practice session/shop tour for those of you that want to meet him, or would like to practice using Zoom. This will be a good chance to ask any questions you might have about using Zoom, and also get to know Ed. You will be able to log in at Wednesday July 15th at 6:45ish for some social time until the actual practice session starts. In addition to getting some minimal instruction on how to use Zoom, you will ensure everything is in place for you to get logged in for the actual Thursday night demo. I assure you, this is worth doing, and it is really easy!

Both the Wednesday practice session and the Thursday remote demo will use the same link. The link will be sent to all active members on Saturday. Our own Ramon Lyn and I will assist Ed as co-hosts. We will admit members logging in to the meeting, and will assist in muting microphones when needed, and getting questions answered as they arise. Again, before joining us, you will need to go through steps 1 and 2 above. You will see how to log into the meeting, how we ensure security, how we keep control of the meeting, and how to mute or unmute your microphone, and how to pose a question to the demonstrator. You can ask us any questions you might have about Zoom during this practice session and Ramon and I will do our best to answer them.

2020 Bi-Monthly President's Challenges

Month	Challenge	Description
March	Lidded Box	Lathe turned lidded boxes
April	Shop Built Jigs	Items built to help make lathe turning more efficient or safer. Examples include, but are not limited to circle cutters, items used to make segments, and stabilizing blocks for cutting off spindles and tenons.
June	Use of Color and Texture	Turned projects enhanced with paint, resin of stone inlay, pyrography, paint, dyes, etc.
August	Children's Toys	Lathe turned items to play with, such as, but not limited to tops, toy rock- ets, croquet mallets, automatons, cryptic boxes, or other items that are lathe turned.
November	Holiday Decor or Gift	Ornaments, table decorations, Menorahs, candle holders and other items used to decorate for the holidays, or a holiday gift that was turned on the lathe.
January 2021	"The Podiatrist's Special"	Any lathe turning enhanced by unusual foot treatment. Judging will be based on how the foot design contributes to the aesthetics of the overall project.
