September President's Message

September's Remote Demonstration: On Thursday, September 17th at 7:00, please join us to see our own Eric Lofstrom, who will present his "Skew Skills "Making the Cuts" demo! I have seen Eric demonstrate skew skills several times, and anything I know about using a skew, I learned from Eric. I assure you that you will see a real master teacher and woodturner. If you apply what Eric will show you to your own work, it will result in cleaner forms and cleaner cuts!

Eric is an artist who is well known for lathe-turned projects featuring cleanlined forms. He has several series of turnings that are related to each other, but at the same time they vary from each other in grain, color, and texture. He has presented demonstrations and hands-on classes all over the US, including AAW clubs, woodworking stores, and symposiums. In the past, Eric has presented at the Creativity in Woodturning Symposium in Washington State (2008, 2009), Oregon Woodturning Symposium (2015, 2019), Utah Woodturning Symposium (2015), Mid-Atlantic Woodturning Symposium (2016), Rocky Mountain Symposium (2017), Southwest Area Turners Symposium (2017), AAW National Symposium (2018), and the Tennessee Association of Woodturners Symposium (2020).

In this session, you will learn basic spindle turning with the skew, simple sharpening techniques and methods to obtain an ultra-clean cut. You will experience several exercises using biomechanics to increase tool control and gain confidence at the lathe. This demonstration will also showcase skill-building projects; the egg and my version of the finger-tip spinning tops. The experience of using the skew and the lessons learned during this demo will expand your success with ALL cutting tools!

Tools Available: We often get questions about where can I buy a lathe or equipment. Well, here is your chance! Long-time member, Alan York is retiring from the hobby and is selling all his turning equipment. He has a 24" swing Jet lathe, chucks, tools, faceplates, wolverine sharpening jig, and all the little things that woodturners accumulate. | March | Lidded Box | Lathe turned lidded boxes | |
| April | Shop Built Jigs | Items built to help make lathe turning more efficient or safer. Examples include, but are not limited to circle cutters, items used to make segments, and stabilizing blocks for cutting off spindles and tenons. | |
| June | Use of Color and Texture | Turned projects enhanced with paint, resin of stone inlay, pyrography, paint, dyes, etc. | |
| August | Children's Toys | Lathe turned items to play with, such as, but not limited to tops, toy rockets, croquet mallets, automatons, cryptic boxes, or other items that are lathe turned. | |
| November | Holiday Decor or Gift | Ornaments, table decorations, Menorahs, candle holders and other items used to decorate for the holidays, or a holiday gift that was turned on the lathe. | |
| January 2021 | "The Podiatrist's Special" | Any lathe turning enhanced by unusual foot treatment. Judging will be based on how the foot design contributes to the aesthetics of the overall project. | |



Zoom Meeting If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)

- 1. The Zoom meeting invitation is only sent to active members. So, if you have not paid your dues since October 2018, you will need to go to the members tab on the SPSW website (http://spswoodturners.org) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.

- 2. Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!
- 3. Information and Invitation Delivery Schedule:
 - Saturday Sept. 12th The Zoom Meeting Invitation will go out to our active member's distribution list.
 - This invitation contains a link that appears in blue letters.
 Just click it to join the remote demo on Thursday.
 - ii. Please save this where you can find it.
 - 1. If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
 - b. **Wednesday Sept. 16th** A reminder will be e-mailed to our active member's distribution list.
 - c. Thursday Sept. 17th Log into the meeting between 6:30 7:00.
 - i. The meeting will start at 7:00 PM PDT.
 - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
 - iii. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
 - iv. Devices used to view the demo can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.
