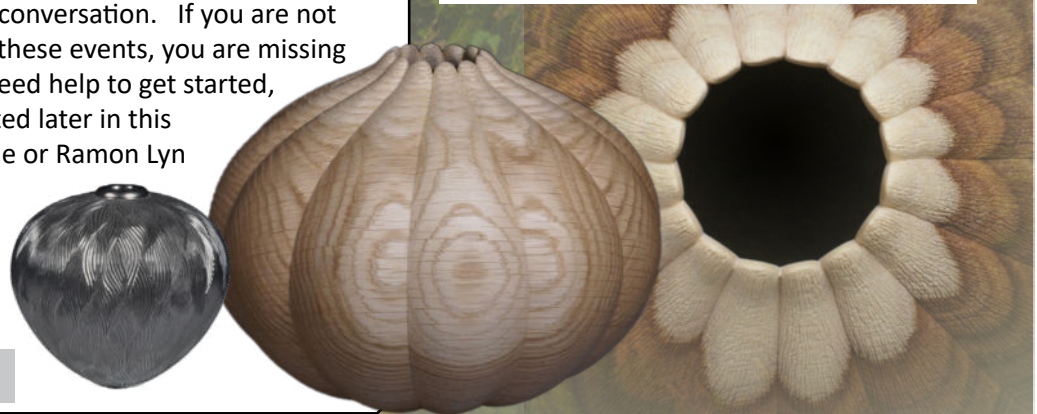
March's Remote Demo: John Jordan

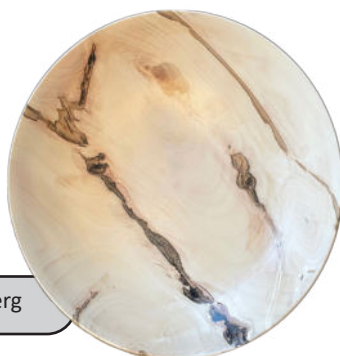

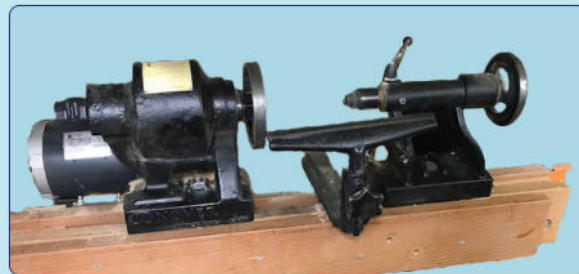
Classified Ads -Another Member Benefit:

In 2020, the AAW sponsored Zoom based interactive remote demonstrations by internationally known woodturners available over a three-day period all for \$20. 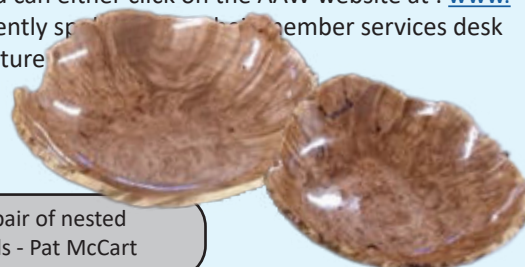
Welcome Kent, the new AAW liaison

Membership Dues

Thank you to all of you that have already renewed your membership in the SPSW for 2021! So far, we already have 89 renewed 2021 memberships.

I need to alert everyone to something that is coming up. We have a number of members currently on our active list that have not paid dues in either 2020, nor so far in 2021. **Everyone should be aware that on or about April 1st we will be doing the annual purge of the membership roster.**

This action removes access to SPSW services available for those folks that have not paid membership dues in either 2020 or 2021. People who are removed from the active members roster will be not receive invitations to the Zoom remote demonstrations, nor will they have access to the "Members Only" tab the SPSW webpage. Active Member Registration



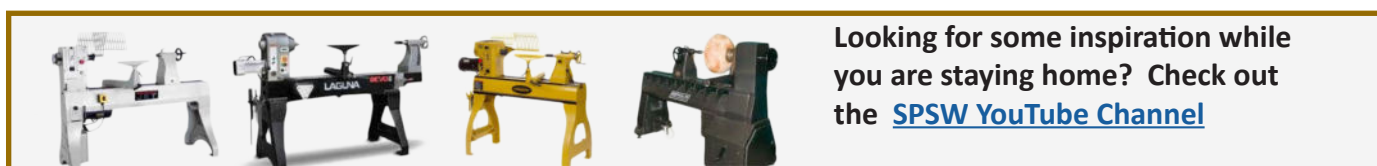
Have you noticed that you don't get all the communications that some other SPSW members get or that you are unable to view the meeting/remote demo videos? In order to get all benefits for active members, you need to be registered on our website and signed up for our member communication email list. Only about half of our paid-up members are completely registered and signed up. If you aren't registered, it is an easy problem to correct. Open our webpage at www.spswoodturners.org and click on the "For Members" tab. The drop-down menu's first choice is "How to Register". Click on it, and there will be a short video that explains exactly how to get registered. After your registration is approved, the second step is required to complete the process. Go to our webpage and click on the "Member Communication Sign-up" under the For Members menu and follow the instructions.



Zoom Meeting If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)

1. The Zoom meeting invitation is only sent to active members. So, if you have not paid your dues since October 2019, you will need to go to the members tab on the [SPSW website](http://spswoodturners.org) (<http://spswoodturners.org>) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.
 - a. Those of you who get the newsletter by snail-mail will need to get us an e-mail address where we can send your meeting invitation. Please send it to (membership@spswoodturners.org)
2. Before the scheduled meeting, you need to go to [zoom.com](https://zoom.us) and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!
3. **Information and Invitation Delivery Schedule:**
 - a. **Saturday, March 13th** – The Zoom Meeting Invitation will go out to our active member's distribution list.
 - i. This invitation contains a link that appears in blue letters. Just click it to join the remote demo on Thursday.
 - ii. Please save this where you can find it.
 1. If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
 - b. **Wednesday, March 17th** – A reminder will be e-mailed to our active member's distribution list.
 - c. **Thursday, March 18th** - Log into the meeting between 6:30 and 7:00pm
 - i. John's demo will start promptly at 7:00pm.
 - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
 - iii. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
 - iv. Devices used to view the demo can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.

For Zoom Security, Please Rename If Needed: We have a number of people that participate in the Zoom demos. When you join the session, you will be able to see yourself and the other participants in thumbnail photos with the name of each person under their picture. If your name appears as "John's iPad", or "iPhone 189567", then we don't really know who you are, which is a security issue. If that happens when you join the meeting, please just click on your name, and then click "rename" and change it to your full name. It will help Ramon and me as we co-host the meeting. Thanks!
