July's SPSW program will be a Mini-Symposium!

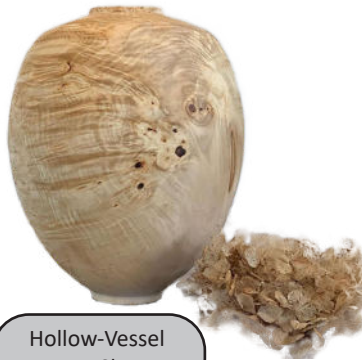

The Board has decided that having a mini-symposium would be a great format for our first in-person meeting, because then members will be able to have opportunities to reconnect and visit with each other. For those unfamiliar with the mini-symposium format, there will be several members giving simultaneous demonstrations and activities. There will be lathe demos focusing on hollowing, basic turning, making baby rattles, and adding interest to turnings using branding/wood burning techniques.

There will also be a "flea market" table for buying and selling turning tools, so if you have some to sell, put a price on them and bring them to the meeting. Pat McCart will have the club's bench grinder and CBN wheels set up to demonstrate tool sharpening. So if you would like to learn how to sharpen, bring a couple tools and Pat will help get you started. Fred will show you how to photograph your work and will actually take pictures of some of your work if you will bring a couple of pieces to the meeting. There will be a wood sales table, membership table, and a mentoring table. Also, Ken Light will have a Store Sales table where you can buy glue, abrasives, finishes, and other items at great prices.

The best way to get a lot out of a mini-symposium is just wander around, and see whatever you're interested in. Please take advantage of the opportunity to meet some new friends and learn some new techniques.

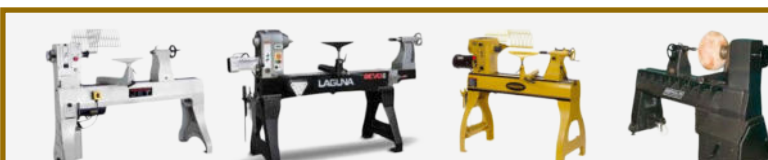

Annual Wood Auction

Historically, instead of a Sawdust Session we have traditionally had a combined wood auction and picnic the weekend after the July meeting. It has been a great get-together, a chance for members to buy enough wood at bargain prices to keep them busy all year, and a nice fundraiser for the SPSW! The board is happy to announce that we will be able to hold the auction again this year. However, we will not do our traditional potluck dinner, because we are just coming out of COVID restrictions, and many are not fully comfortable being crowded into an interior space as we have done the past.



So instead of a potluck, we are asking people to bring their own food, chairs, and tables. We plan to arrive at the North Lake Improvement Club at about 11:00 and set up for the auction. We will eat at about 12:00, and then start the auction right after lunch.

Over the past year, our club's wood-rat (Doug Reynolds) has coordinated multiple cutting parties where we have been able to acquire some really wonderful wood. There will be highly figured maple, box elder, black walnut, locust, monkey puzzle, holly, oak, and many other species. Sizes range from big slabs and rounds, all the way down to pen blanks, and everything in between! Almost all of this wood has been sealed with Anchor Seal and is ready for further processing. If you need something cut down after you buy it, there will be a couple of chain saws at the auction too.

Honestly folks, take advantage of this. Access to this auction is considered by many to be a huge benefit of belonging to the SPSW! There are woods here that aren't generally available in stores. And if you were to try to buy some of this wood in a store, it would be prohibitively expensive. Lots will contain several pieces of wood, and usually go for \$20 - \$30! It is the deal of the year.

You will also have access to people who can help you get started on how to seal the wood to minimize checking, explain the advantages of green wood turning, rough turning, and coring processes. 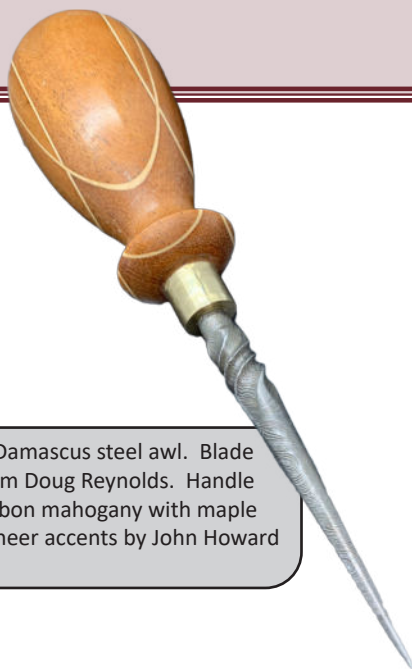

Zoom Meeting If you haven't been on Zoom before, just follow the steps below. **(If you have been in a Zoom meeting before, just start at step 3.)**

1. **The Zoom meeting invitation is only sent to active members.** So, if you have not paid your dues since October 2019, you will need to go to the members tab on the [SPSW website](http://spswoodturners.org) (spswoodturners.org) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.
 - a. Those of you who get the newsletter by snail-mail will need to get us an e-mail address where we can send your meeting invitation. Please send it to (membership@spswoodturners.org)
2. Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!
3. **Information and Invitation Delivery Schedule:**
 - a. **Saturday, June 12th** – The Zoom Meeting Invitation will go out to our active member's distribution list.
 - i. This invitation contains a link that appears in blue letters. Just click it to join the remote demo on Thursday.
 - ii. Please save this where you can find it.
 1. If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
 - b. **Wednesday, June 16th** – A reminder will be e-mailed to our active member's distribution list.
 - c. **Thursday, June 17** - Log into the meeting between 6:30 and 7:00pm
 - i. Steve's demo will start promptly at 7:00pm.
 - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
 - iii. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
 - iv. Devices used to view the demo can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.

For Zoom Security, Please Rename If Needed: We have a number of people that participate in the Zoom demos. When you join the session, you will be able to see yourself and the other participants in thumbnail photos with the name of each person under their picture. If your name appears as "John's iPad", or "iPhone 189567", then we don't really know who you are, which is a security issue. If that happens when you join the meeting, please just click on your name, and then click "rename" and change it to your full name. It will help Ramon and me as we co-host the meeting. Thanks!
