

### CASTING with Ken Light February 17th, 2022

I deciced I wanted to add fabric to a seam ripper. That is what began my quest. Doing so was not as easy as I thought it would be. Once I figured out how to add the fabric I began making seam ripper & pen sets. My demonstration will be on adding fabric to a pen and seam ripper casting. I will be sharing my failures and learning experience as I show how to do it.

### **Saturday Sawdust Sessions**

Our Sawdust Session is happening on February 19th, the Saturday after the February general membership meeting. Our last Sawdust session was spectacular with 12 people in attendance. We had 3 lathes going and the sharpening station. Pat McCart had a great demonstration on his OneWay Coring system. The sawdust session is an excellent opportunity for all members to come, join in the comradery of working with other members to learn a variety of new skills or improve on some old ones and share with new turners a skill they may be struggling with. We meet in a member's shop and we have 3 or 4 lathes all going at once. Wayne Wells has generously offered us the use of his shop for these activities. If you would like to attend, just join us at Wayne's. The address is 12012 28th Ave E, Tacoma 98445. It is just off 112th, between the Summit and Parkland areas.



One of our more experienced members is at each lathe showing people how to make good, clean, and safe cuts at the lathe. We can usually put the tools in the hands of people who have never turned anything before. We can also assist with learning how to sharpen tools.

Sawdust sessions are one of most valuable benefits of belonging to the SPSW. We usually have some very new woodturners, some intermediate turners who might have a project with them that they are stuck on, and some very experienced members to help anyone that needs it. We all have great time!

#### **SPSW Store**

water! If you just cut wood and wait for it to dry naturally, it will often be ruined by cracks and checks. This can be avoided by slowing the drying process. One of the best ways is by sealing the end grain on the wood. Anchorseal 2 is a commonly used product slowing water loss and drying. We sell it for \$18.00/Gallon, which is a significant savings over other sources. Also, Anchorseal 2 is freeze stable! This is a product that should be part of almost every member's shop. I highly recommend it!

explain the advantages of green wood turning, rough turning, and coring processes. **Zoom Meeting** If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)b.

- 1. **The Zoom meeting invitation is only sent to active members.** So, if you have not paid your dues since October 2019, you will need to go to the members tab on the <u>SPSW website</u> (spswoodturners. org) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.
  - a. Those of you who get the newsletter by snail-mail will need to get us an e-mail address where we can send your meeting invitation. Please send it to (membership@spswoodturners.org)
- 2. Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!
- 3. Information and Invitation Delivery Schedule:
  - a. **Saturday, Feb 12** The Zoom Meeting Invitation will go out to our active member's distribution list.
    - This invitation contains a link that appears in blue letters. Just click it to join the remote demo on Thursday.
    - ii Please save this where you can find it.
      - If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
  - b. Wednesday, Feb 16th A reminder will be e-mailed to our active member's distribution list.
  - c. **Thursday, Feb 17th** Log into the meeting between 6:30 and 7:00pm
    - i. Ken's demo will start at 7:00pm
    - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
    - iii. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
    - iv. Devices used to view the demo can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.
