### **January Demonstrator - Devin Garlick**

My story starts when I was about 8 years old. My dad was a cabinet maker and I was invited to his shop to help him balance plywood as he cut it on the table saw. That was the beginning of my obsession with woodworking.

20 years ago I started cutting trees as a side-gig and five years ago I decided to go out on my own being so booked out for work. It wasn't until about 4 years ago that we came across the demonstrators from the Olympia Woodturner's club that mesmerized my wife. That is all it took for me to finally get a lathe and spend time in my shop just 'practicing'. I was on the fast track in learning about what is beneath the bark. After about a year of cutting trees full time, I got into wood turning and have not looked at a tree the same. I have since learned the names and characteristics of the trees that I am cutting: Black Locust, fruit woods, Maples, Holly and Sycamore to name a few. Now I see crotches, burls, color, figure, spindles, bowls, hollow forms, boxes and many other things.

After attending my first meeting at the SPSW, I took my wife to the Sawdust Session over at Nancy's where we were invited to several members' shops to work on our turning skills. Harry Lincoln brought us over and showed us around and I was able to go with him and Roy Lane on a few harvests where he imparted his many decades of knowledge. Gary Thompson was also at that sawdust session and seeing the glow on my wife's face invited us to go to his shop to turn as well. Of course I couldn't let my wife show me up and had to use his pier block lathe, it is a monster, but oh so much fun to turn on.

Harry had a saying that I have found to be true: "Some wood is for turning and some wood is for burning."

### A Word From Kent Horton

Hello again, this is Kent Horton your SPSW/AAW liason. Every few days I get an email from AAW's Exchange regarding Chapter Leadership issues. This is an ongoing forum whereby different chapter leaders within the AAW universe have an opportunity to bring up questions for discussion various issues that other clubs might have in common. I always find it interesting to read these conversations from clubs across the country and beyond and the different ways these clubs have dealt with the issues. Many clubs have the same issues and questions that mirror these we have at SPSW. Earlier conversations have centered on the transition from in-person meetings to remote meetings during Covid and the needed

technology to make it be successful, and now how to deal with hybrid meetings.

A recent entry by Mark Toomy, president of the Central Illinois Woodturners, spoke to their club's long-term project of turning wig stands for cancer patients. In this article, Mark describes the lessons his club has learned over the 5-years (and some 1500 wig stand) they have been producing their wig stands in hopes of helping other clubs be more productive if they were to embark on a similar effort. I applaud them in their focus on supporting local cancer centers. Not only do they collect needed wood and mill it to size to make "kits" that members take to produce the final product, they also work with local schools to enlist art students to decorate and embellish the unfinished wig stands prior to distribution. They also use this project to provide an opportunity to teach new club members basic turning skills. This is but one example of an outreach program that connects local clubs to the greater community.

Another idea presented in these exchanges was that some clubs have a monthly "challenge" that their members turn items based on a theme. AAW does this through their Member-Moderated Forum each month. Suzette, our wonderful newsletter producer, participated in December's event by submitting a pair of "Snow People." While not winning first place in the on-line voting process, she did garner 14.3% of the total votes out of the 13 entries – way to go Suzette! The theme for January is "Turn a Kitchen Implement" – If interested, you can check out the guidelines in the AAW website under "Forums."

The most recent discussion thread deals with whether clubs should or should not make their contact information available outside the club – example: email addresses of club members available to venders who support the club with discounts. Frankly, I have mixed feelings on this issue. It seems I am constantly being bombarded with unsolicited offers and generally don't like the idea of my personal information out there for all to have access to. Perhaps this is an issue we need to look into and develop a clear and concise club policy.

Once again, my goal is to promote SPSW members to also become members of AAW. If you are not already a member of AAW, please consider becoming one.

**Zoom Meeting** If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)b.

- 1. **The Zoom meeting invitation is only sent to active members.** So, if you have not paid your dues since October 2022, you will need to go to the members tab on the <u>SPSW website</u> (spswoodturners. org) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.

- 2. Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!

  - a. **Saturday, Jan 14th** The Zoom Meeting Invitation will go out to our active member's distribution list.
    - i This invitation contains a link that appears in blue letters. Just click it to join the remote demo on Thursday.
    - ii Please save this where you can find it.
      - If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
  - b. Wednesday, Jan 18th A reminder will be e-mailed to our active member's distribution list.
  - c. Thursday, Jan 19th Log into the meeting between 6:30 and 7:00pm
    - Devin's demo will start at 7:00pm
    - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
    - iii. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
    - iv. Devices used to view the demo can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.
