#### A Word From Kent Horton

Hello again, this is Kent Horton, your SPSW/AAW liaison.

I am going to begin with my 2023 mantra:

"If you, as an SPSW member, and want to up your turning game, you should seriously consider joining AAW."

This month's "American Woodturner" (February 2023, vol. 38, number 1) has some interesting and useful articles on sharpening:

- Dennis Belcher's article "Introduction to Sharpening" provides an excellent guide to understanding the how's and why's of sharpening.
- Lyndal Anthony's article "A Look at Gouge Geometry" deals with perfecting the sharpening of the workhorse in a turner's stable of turning tools. This is one area I have long struggled with and have produced all too many "MAJOR" catches due primarily to improper sharpening. Now it is a matter of perfecting the sharpening process for my gouges at the grinding wheel and then, lots of practice.

Jimmy Clewes, a well known and highly regarded professional woodturner, writes a detailed article on how he creates his signature ceremonial shield from mounting, rough shaping, creating the rim detail, through adding rim studs and embellishing with gold leaf. The end product would enhance the look of any number of castle walls.

Silas Wareham details the making of an adjustable-height side table that looks like an enlarged Phillips-head countersink screw. This project, while not my style, does provide a number of turning and construction challenges.

The next article I wanted to share with you is by J. Paul Fennell, who describes (in wonderful detail) the process he uses to create asymmetrical and heavily sculpted pierced objects. As I read the article I kept thinking of Dave Best's club presentation a few month's back on what it takes to make a finished pierced bowl and how much more involved Mr. Fennell's work entails – indeed, I confess I don't possess the required patience, but the results are amazing.

The final article from this issue of "American Woodturner" is regarding the collaborative efforts of WIT (Women in Turning) group within the AAW community. Groups of women turners get together virtually to create a wide spectrum of turned objects with the goal of taking the next "scary" step of collaborating with fellow women turners. Our own Suzette Edwards has participated in this event and found it challenging in many aspects. I applaud her willingness to get out of her comfort zone and join in the collaboration process.

#### Demo Review - Devin Garlick on How You Cut a Log Determines the Figure in Your Bowl

The January demo was by our own Devin Garlick. He gave detailed information on how the cuts in the wood



determines the figure in a bowl. He had examples of how different cuts worked. There were some microphone issues thanks to a cable that had gone bad. For those on Zoom it was gravelly and hard to understand. The good news is most of that has been cleared up on the uploaded video. We can thank Ramon Lyn for recording the in-house audio so it was possible to put that into the video. It is a bit quieter so you will have to turn up the volume a little.


Devin showed us difference figuring in a bowl and even did drawings as to where that figuring came from.

Devin explained the different parts of the tree and how it affects turning.

Have you ever wondered about burls? Well, Devin explains quite a bit about burls (starting around the 50 min mark). He even showed how the grain (yup, there is grain) goes in a burl compared to how it relates to the tree. Check it out around 51:30 mark

Devin gave away a couple of pieces of wood. (At the 1 hour mark) One was for a winged bowl to be made and the other was a chunk of fiddleback. It will be fun to see what is made from that one. The grain is stunning.

If you missed the demo be sure to check it out on the SPSW website under the member tab, It is well worth watching.

#### **2023 Membership Renewals**

**Zoom Meeting** If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)b.

- The Zoom meeting invitation is only sent to active members. So, if you have not paid your dues since October 2022, you will need to go to the members tab on the <u>SPSW website</u> (spswoodturners. org) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.

- 2. Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!

  - a. **Saturday, Feb 11th** The Zoom Meeting Invitation will go out to our active member's distribution list.
    - This invitation contains a link that appears in blue letters. Just click it to join the remote demo on Thursday.
    - ii Please save this where you can find it.
      - If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
  - b. Wednesday, Feb 15th A reminder will be e-mailed to our active member's distribution list.
  - c. **Thursday, Feb 16th** Log into the meeting between 6:30 and 7:00pm
    - i. Dan's demo will start at 7:00pm
    - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
    - iii. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
