## April Demo The "Best" Techniques - Dave Best

#### Puzzle it Out!

Have you ever enjoyed the slightly confused look from someone examining one of your completed pieces and the follow-up questions around how you accomplished one or more aspects of that piece? Well, our April Demonstrator has on more than one occasion. Don't miss this one! Forever club member, Dave Best will be sharing some of his Best Techniques developed over the years in creating his unique pieces.

Dave's tenure with the SPSW club reaches back to the very first meeting in 1992 or 1993. At that time, He was working fulltime and had a young family, so he could not afford the time to drive up to Seattle to attend the only woodturning club meeting in the area. Then he heard through a friend, Tom Richards, that a meeting was to be held at the Fife Community Center to form a new local woodturning club and he should attend. Dave not only attended that first meeting along with 40 to 45 other men, he joined the club that night. Over the subsequent thirty plus years Dave was not always able to attend the meetings, but he stayed connected with the club. When his life allowed, he stepped up to a larger role and supported the club in the role of VP and Director of Programing. Something near and dear to me.

Dave served in that capacity for seven years. These days, one can often find Dave busy taking quality photographs of club member pieces that are brought to our monthly meetings. Many of these images are then shared in this monthly newsletter! Thanks Dave!

Not surprising to most long-term members, Dave sees the club as kind of like a family, where everyone enjoys themselves and each other. He is thankful for the many different resources from which to learn new things and the easy-going camaraderie he has enjoyed over the years. Dave likes the direction that the club is going and sees the club's recent move to the WSU, Puyallup Research and Extension Center facility as a good thing. The lower costs and improved facilities are positive. He also thinks the continual addition of new members to the club is healthy for sustainability.

As Dave progressed with his woodturning skills, he found that making simple bowls was just not enough. He wanted something more, something different. Dave wanted to go beyond the basic bowl shape, he wanted to add color, texture and other features to make his work unique and interesting.

Growing up in Minnesota where winter could last from October through April one needs something to occupy your time while staying indoors. When he was about 9 years old, Dave's family moved in with his grandparents. That move provided young Dave with access to a basement shop. It was here he developed his early interest in woodworking and learning how to use tools and how to make stuff. Along with this early practical education, Dave began to understand the fulfillment and joy of making something yourself, gaining skills and slowly building the confidence to take on the next challenge. These experiences laid the seeds for his creative journey in woodwork and woodturing.

Years later Dave began to further nurture his creativity and yearn for that something more by attending extended courses from talented woodturning artists. Two of these week-long courses took place at Arrowmont – School of Arts & Crafts in Gatlinburg, Tenn. One of the courses was instructed by J Paul Fennel and included instruction on Basketweave Forms. Joining Dave for the second course John Howard and Jeff Marshall was instructed by Avelino Samuel. Dave has also attended many demonstrations from talented woodturners and artists in the Pacific Northwest, among the demonstrators were Trent Bosch and John Jordan. Dave says his style has certainly been influenced by each of these artists and others. One of his key takeaways from these courses is learning not to be afraid of making a mistake.

I asked Dave what advice he has for new members and new woodturners. He replied, "Don't be afraid to get out of your comfort zone. Bring your pieces to the club meeting to show. Get feedback. Learning from YouTube is fine, but learning face to face is far better."

Of course, I had to ask Dave whether he considered himself a craftsman or an artist. He replied, "Learning to turn a bowl is the craftsman part. Turning that piece and then doing something with it is more of the artist." Beyond turning a bowl, Dave is intrigued by the options to do something to the surface, put your signature on it. He feels there is a real reward for trying something new and Puzzle-it-out!

"I enjoy having my grandchildren join me in the shop and encouraging them to learn to use the tools to make something. This plants the seeds of doing something and gaining the benefit of knowing for themselves that they have the skills and can make something useful. That belief helps them improvise when problems arise."

For his demonstration, Dave plans to share some clever techniques he learned or developed for three of his creative gems. Each of these pieces share an overall general profile but are completed with very different embellishing processes. He plans to demonstrate layout techniques for creating a basket weave pattern. Dave will also demonstrate the steps necessary to achieve the lime waxing finish. Finally, he will share key processes for what he describes as his turned, carved, textured and burned piece.

For those intrigued by Dave's presentations and desire additional guidance, he has always offered an invitation to visit his shop in Graham, WA.

#### A Word From Kent Horton

Hello again, this is Kent Horton your SPSW/AAW liaison with yet another edition. Again, my mantra

- "If you are serious about improving your woodturning skills, you owe it to yourself to join AAW and take advantage of their many resources dedicated to the craft/art of woodturning."

I recently receive my April 2025 issue of *American Woodturner* and thought I might speak about a couple of articles.

Have you ever looked at a "turned" object and asked yourself. "How in the world did they do that?" I've seen several twisted tubes and forms over the years and asked myself that very same question. Inside the front cover is a short article on Lou Wilde Ireland that explains that by turning a long cone-shaped spindle and then cutting it apart on the bandsaw at various angles (with a holding jig to safely cut the pieces) and then reassembling the pieces, one can create a twisting shape followed with a lot of rasping and sanding to make a snake-like final shape that is a continuous 3-D curl. Another of Mr. Ireland's pieces requires carving and shaping after completion of the turning. The donut with spikes is one example shown in this month's American Woodturner. This process takes what Pat McCart does to make the legs on his 3-legged bowls to a whole new level. Wow, indeed.



One of the major articles was on Art Liestman's creations using a therming jig to make rectangular tea pots. While I think I understand the process in theory – I still wonder "How in the heck. . ."

Jim Sannerud has an article on moving away from synthetic petrochemical finished to using safe, nontoxic products, many which have been around for a long time. His is a personal journey that explores the many nature-based products that are available today. Jim speaks to using urushi, or Japanese, lacquer and how it can cause severe allergic reactions with some people. I recall our own Ed White having an adverse reaction following his attendance at one of the presentations at the Oregon symposium. A cautionary tale to be sure.

I should also mention that if you are into fishing, this issue of **American Woodturner** is for you, from making a sold wood handline (Fishing rod-less fishing using a 7-inch dowel-like line holder, to making a trout net with a turned handle. Having only "fished" at a local trout farm many, many years ago, I couldn't tell you anything about fishing.

This month's issue of *American Woodturner* is quite interesting.



### **Bitter Cherry (Prunus emarginata)**

I cut this tree about two years ago and turned the bowl on 3/6/25. Upon roughing it, I found the moisture content below 10% deep into the wood. It cuts very well, smells nice and sands

well. It has attractive grain and color and is dense enough to take texture well. Other than MAYBE madrona, this might be the only native species we have suitable for texturing. This piece was sanded to 320 and finished with my DIY friction paste topped with carnauba wax. In the future I will cut logs of this species to get the clearest wood

possible, although there's nothing wrong with branch piths, crotches and so forth. The clear portions of this wood are every bit as nice as eastern cherry, it's just lighter in color.

I believe the prejudice some of us have against this wood is unfounded.

**Zoom Meeting** If you haven't been on Zoom before, just follow the steps below. (If you have been in a Zoom meeting before, just start at step 3.)b.

- 1. **The Zoom meeting invitation is only sent to active members.** So, if you have not paid your dues since October 2023, you will need to go to the members tab on the <a href="SPSW website">SPSW website</a> (spswoodturners.org) and renew your membership. Please note that it would normally cost more for just one of these demonstrations than your SPSW dues for the entire year.
- 2. Before the scheduled meeting, you need to go to zoom.com and download the free "Zoom Meetings" app. The Zoom download is quick, easy, and free!
- 3. Information and Invitation Delivery Schedule:
  - a. **The Wednesday the week before the meeting** The Zoom Meeting Invitation will go out to our active member's distribution list. (This is if we get the link by then)
    - This invitation contains a link that appears in blue letters. Just click it to join the remote demo on Thursday.
    - ii Please save this where you can find it.
      - If you don't see the invitation(s) in your inbox, then please check your "junk" or "spam" folder. If you get our newsletters, the meeting invitation should come right into your inbox.
      - 2. If you did NOT get the email, the link will be posted on the SPSW website under For Members/Zoom Meeting Link
  - b. **The Saturday before the meeting.** A reminder will be e-mailed to our active member's distribution list
  - c. The day of the meeting Log into the meeting by 6:30pm
    - i. The demo will start at 7:00pm
    - ii. When you click on the link, you will be asked if you want to join with video and audio. Answer "yes" to both, then you will enter a virtual waiting room. Wait just a few seconds and one of the co-hosts will admit you into the actual meeting.
    - iii. **Note:** If you have previously downloaded the app, you may see an update is available. If you see it, please update your app. Zoom is making frequent changes to the program to strengthen security.
    - iv. Devices used to view the demo can be smartphones, tablet computers, laptops, etc. To fully participate, the device needs to have audio and a camera.
